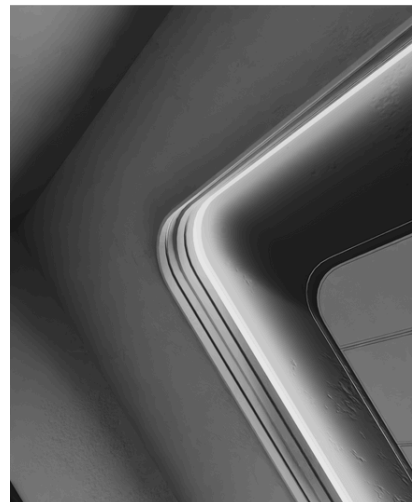
## 4. Organizational Structure

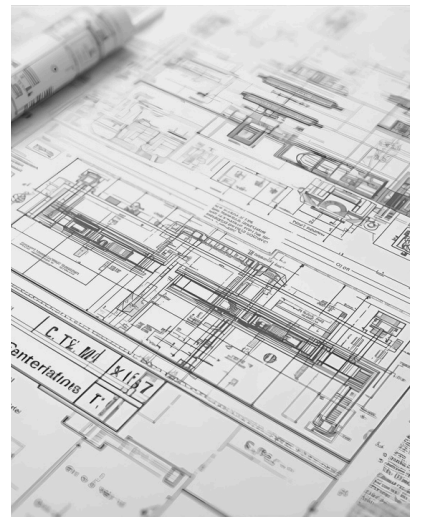
## 5. Manpower & Resources

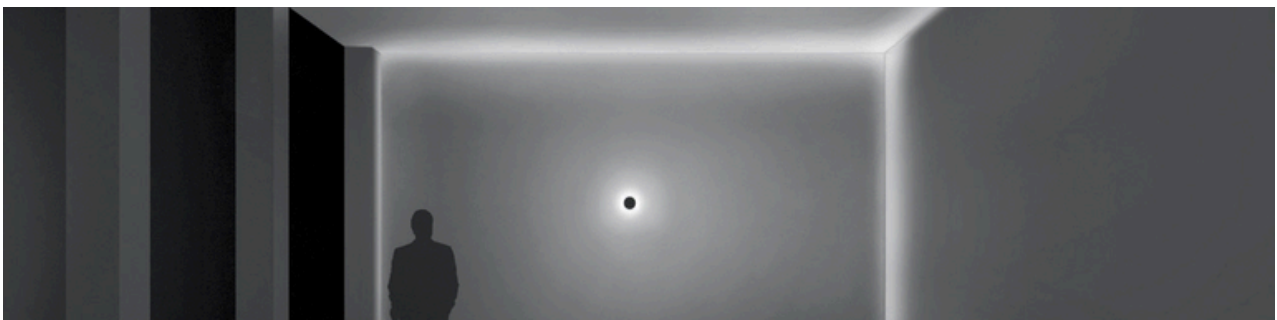

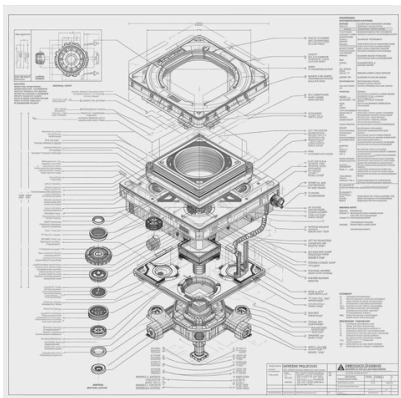
